Raisins coated with sugar sweetened carob coating then polished with a gum Arabic solution and sealed with edible shellac.

**Lot Coding:**

Each bulk packaged case is labeled with product name, ingredient list, net weight, applicable kosher certification, and lot number/date code.

Date coding is done in Julian format (DDYY) based off of date of manufacture.

Ex: 06317 = 063 (March 4, 2017). The appearance of a “B” indicates second shift.

Retail Packaged items are coded with a “Best By” date based off of manufactured date in the below format:

Ex: 03/04/17P1 = Best By Date followed by a letter indicating production line, followed by a number indicating shift.

**Allergen Statement:**

An allergen control program is in place to minimize contamination.

Manufactured in a plant that processes peanuts, tree nuts, soy, wheat (gluten), eggs and dairy products.

All products are manufactured on shared equipment with milk containing products; incidental milk may be present.

The use of “Coconut Oil” in our panned products is used solely as a processing aid and is stated as “highly refined” from the manufacturer making it exempt from allergen labeling as outlined in the Federal Food, Drug, and Cosmetic Act (21 U.S.C. 321 note).
